### Phishing Alert: Protect Yourself from Scams

ASHI has been informed that phishing scam messages have been targeting our inspectors through the Find An Inspector feature. These fraudulent emails may appear to come from trusted sources, but they aim to trick you into revealing sensitive information or sending money.

**Always be cautious of urgent requests, unfamiliar email addresses, or suspicious links.** Never share personal or financial information via email, and verify any requests by contacting the organization directly. Stay vigilant and protect yourself from scams.
