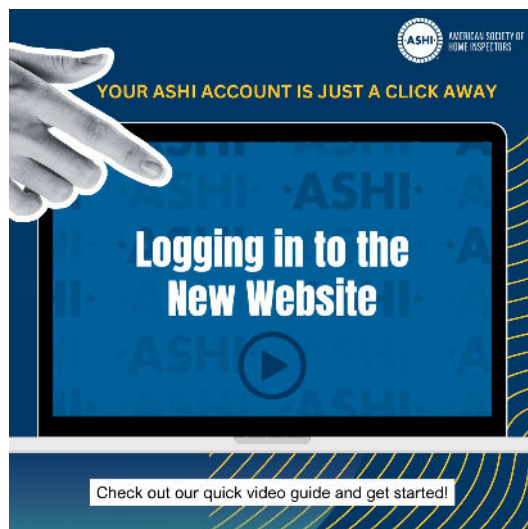

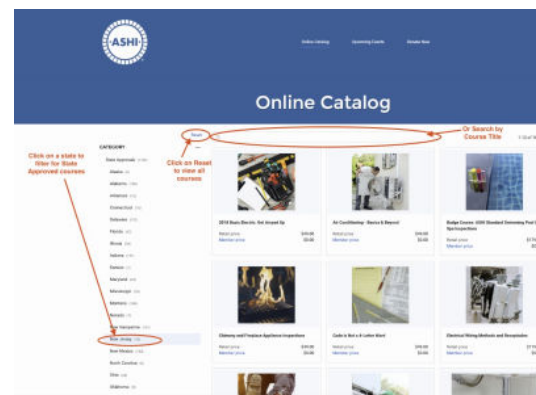

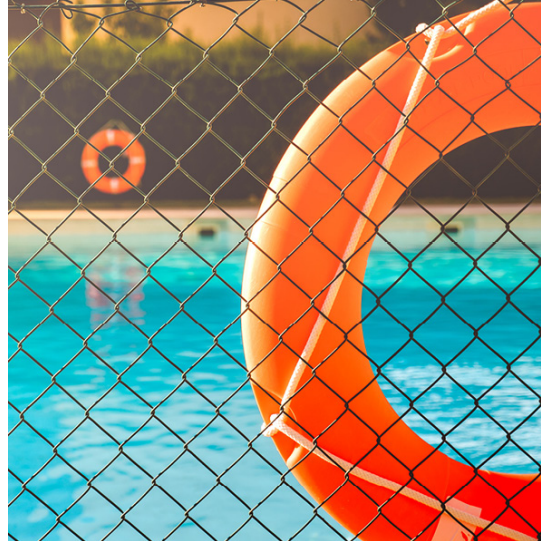

New Beneficial Ownership Rules Now in Effect

[A new update from the Financial Crimes Enforcement Network \(FinCEN\) on Beneficial Ownership Information](#) is now in effect for businesses of all sizes, including small ones.

ASHI members are encouraged to consult their local tax advisor or attorney to determine if this affects their business and if filing is required. For more details, [you can review the official document here](#).

Non-compliance could result in criminal penalties, imprisonment, or fines, so it's important to act promptly.
